It provides Leasing assistance and supported services. The program is a full participant in the community's Coordinated Intake and Assessment initiative - housing the area's most vulnerable of homeless persons. The program also utilizes the services of a SAMSHA funded STAR program which provides in home substance abuse treatment services.


