Mental Health Resource Center's Coordinated Intake Expansion Program will increase the Continuum of Care's ability to reach and assess individuals in need of housing and services. The expansion program will increase the level of services available to Duval, Clay, and Nassau Counties. Intake and assessment staff will be available at multiple sites located throughout the area that are often frequented by individuals who are homeless. Services will also be provided on the street to those individuals who prefer not to utilize traditional services provided by local agencies.

Mental Health Resource Center will use the Vulnerability Index-Service Prioritization Decision Assistance Tool (Vi-SPDAT) to assess the needs of individuals. The results of the intake and assessment will be used to create one single "by name" list of individuals in need of housing. Individuals will be prioritized based on need and referred to appropriate housing and services as they become available.

The Coordinated Intake Expansion program will also provide assistance to individuals in obtaining the documents needed to enter permanent housing. The program will provide intensive services to those who may have several barriers and require additional assistance in obtaining needed documentation.

Mental Health Resource Center will partner with several service agencies when implementing the Coordinated Intake Expansion program. This will include MHRC working with social service providers in the community to conduct outreach at the service providers' locations. MHRC will also work with housing providers to identify individuals eligible for placement in available housing slots using the "by name" list.

Coordinated entry is advertised at multiple community meetings in an effort to ensure that all those who are providing services to individuals who are in need of housing are aware of the coordinated entry process. Coordinated entry services are advertised on the local lead agency's website for those who have access to the internet. Coordinated entry staff also perform outreach throughout the area at locations that are often frequented by individuals who are homeless. Places such as local crisis stabilization units, jail, emergency rooms, food service lines, drop in

center, and the streets in an effort to reach those with the highest barriers to accessing assistance. Items with Coordinated Intake's contact information are distributed during outreach.

Individuals are assessed at coordinated entry using a housing/service assessment tool. Using results from the assessment and program criteria, individuals are prioritized on one central list based on need and referred to appropriate housing and/or services as they become available.
